1. The courses/holidays at Coeur de Combray, 14270 Ernes are offered to you by SARL Combray Commerce.
2. To reserve a course/holiday, please complete and sign the Booking Form and return it with the non-refundable booking deposit payment. Upon receipt of the completed Booking Form and booking deposit payment, a confirmation will be sent with an information pack.
3. The balance of the course/holiday is payable no less than six weeks before the start of the course/holiday period - If payment is not received by the due date we reserve the right to treat this as a cancellation. We shall, however, send a reminder. Reservations within six weeks of the start of the course/holiday period require full payment at the time of booking.
4. The tenants of our accommodation or Salle de Fête, or participants in a course/holiday offered by SARL Combray Commerce accept full liability to the owner for the costs of damages, breakages or failure to leave the property in a clean and orderly condition. Any costs will be explained and charged for appropriately.
5. We advise comprehensive travel insurance to be taken out at the time of booking, which should include cancellation cover, full cover for the tenant's personal belongings and public liability as the owner's insurance does not cover these items.
6. The properties will be ready to occupy from 4pm on the day of arrival and should be vacated by 10am on the day of departure, unless otherwise stated in your information pack. All properties must be left as found in a clean and tidy state.
7. The owner is not liable to the tenant for:

Any faults or interruption to the supply of public services to Coeur de Combray.

Any loss, damage or inconvenience caused to or suffered as a result of weather conditions, riots, wars, strikes or other matters beyond their control.

Any loss, damage or inconvenience suffered if the holiday property becomes uninhabitable before the start of the rental period. In this unfortunate event a full rental refund will be made. No further liability will be accepted by the owner.

Any changes, made to the itinerary of the course/holiday booked.
